FINANCIAL INFORMATION UPDATE FOR RESULTS BRIEFING

This announcement is made by Laopu Gold Co., Ltd. (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the Company’s announcement dated March 11, 2026, in relation to, among other matters, the 2025 annual results briefing to be held by the Company at 10:00 a.m. on Tuesday, March 24, 2026, where the Company’s management will explain the Company’s results for the year ended December 31, 2025 as well as its recent business operations, and will engage in communication with the participants.

For the purpose of enabling the Company’s shareholders (the “**Shareholders**”) and investors to have a more timely and comprehensive understanding of the Group’s performance, the Company hereby concurrently announces the following preliminary estimated financial data of the Group for the first quarter ending March 31, 2026 (the “**First Quarter of 2026**”): For the First Quarter of 2026, the Group is expected to achieve sales (tax-inclusive revenue) of approximately RMB19,000 million to RMB20,000 million, revenue of approximately RMB16,500 million to RMB17,500 million, and net profit of approximately RMB3,600 million to RMB3,800 million.

The data contained in this announcement is only a preliminary assessment made by the Company based on the Group’s current unaudited consolidated management accounts and information currently available as of the date of this announcement, and such data have neither been audited nor reviewed by the Company’s auditor.
